ARTS PRECINCT TERMS & CONDITIONS

Participation in the Yarraville Festival is subject to your acceptance of the following terms and conditions.
Please study these carefully.

We reserve the right to decline any application. Preference may be given to order of application when allocating sites.

Fee: \$45.00 to be paid by cheque or money order with your application.

Site: The approximate stall size is 3m x 3m and comes with no walls or power. Due to the nature of the street we work in, we need to leave certain areas free, which affects the sizing of stalls.

Products: All items in the arts precinct must be handmade in Australia. If they are not of this nature you may purchase a YAF market stall, and you will be placed within the market stalls area. The arts precinct is specifically for artists. It is important that you specify the nature of your art and the types of product you will have on display. Artists failing to do this may have their admission terminated and forfeit their payment.

Environment and waste: The Yarraville Festival Committee do their best to ensure that the festival precinct is left free of waste at the conclusion of the event. Please try to reduce waste by using recycled packaging and materials and please remove ALL waste at the end of the day.

Set up time. The arts precinct will be open to the public between 9am and 5pm. Stall holders must be on site by 8.00am. Festival staff will be on location from 7.00am. If you do not arrive by 8.00am, you may lose your allocated space.

Vehicle movement: vehicle movement is prohibited in the Festival area from 8.30am until 5.00pm. **Vehicles will not be allowed to park or remain on the Festival site.** No exceptions.

Approvals. No one will be allowed to trade at the Yarraville Festival without all necessary permits and approvals.

Alcohol. The sale or provision of alcoholic beverages, except within areas that hold a Liquor License and has pre approval from the festival committee, is strictly prohibited.

Public Liability. All commercial participants and incorporated bodies must provide a certificate of currency for public and products liability to the amount of \$10 million dollars.

Note: The Yarraville Festival Inc. and its representatives will not be held responsible for any loss or damage to person or property howsoever caused including the negligence of the Yarraville Festival Committee Inc. or its representatives or agents and including loss or damage arising out of weather conditions or the cancellation of the event. **Fees are not refundable.**
